2012 Scholarship Information

Each year our tuition is calculated based upon our projected costs. We do not ask paying students to pay for non-paying students. Each year a few caring individuals & organizations do volunteer to assist deserving students who are truly financially disadvantaged.

We recommend that applicants exhaust appeals to their respective schools, service clubs, & music support groups before applying to Sierra Mountain Music Camp. Nevertheless, a strong recommendation from a student's music teacher, instructor social worker or pastor with personal knowledge of a student's financial need & deserving qualities will be favorably considered. A committee elected by the board will review applications & available funds. Please provide the following **required** information as well as the Scholarship Application and \$75 refundable deposit no later than **May 15, 2012**:

1. Completed Registration Form
2. State the amount of tuition you can afford.
3. **Please provide recent W-2 or tax return, unemployment or disability check stub, or other evidence of financial hardship.**
4. **Please include a letter (at least 1 paragraph) from the camper describing their interest in camp, and why they'd like to attend. Parents can assist if needed.**
5. List any other summer camps (church, music, school, sports, etc) you plan to attend.
6. Obtain a letter of recommendation from teacher, instructor or mentor including a statement about the camper's citizenship - will the camper be likely to contribute to the mission of the camp?
7. State the efforts you have made to obtain assistance from other sources (i.e.) schools, grandparents, & service clubs in your communities such as Rotary, Kiwanis, & Lions etc.

Please tell us more about yourself so that we can evaluate whether you meet criteria of scholarships. The board will only consider applications for scholarship accompanied by a completed registration form, supporting documentation and a \$75.00 deposit, which can be refunded if your scholarship is denied.
